- However, Statutory Audit of CAG as well as Internal Audit of Ministry of Health and Family Welfare have pointed out that in some of the Institutes officers/faculty members who are drawing a grade pay of Rs. 10,000/- and Rs. 12,000/- have been granted transport allowance at the rate of Rs. 7,000/- plus DA thereon per month even though they are not entitled to use of official car. This has been viewed as irregular and
- All concerned are, therefore, directed to scrupulously follow the instructions of Ministry of Finance's 3. O.M. No. 21(2)/2008-E-II(B) dated 29 August, 2008 and O.M. No. 20 (5)/E-II (A)/93 dated 25 January, 1994 and extant rules of Government of India issued from time to time while regulating the Transport Allowance to the officers/faculty members of their Institutes. In case the payment of Transport Allowance at the rate of Rs. 7,000/- plus DA thereon is still being paid to non entitled officers/faculty members, the same may be stopped immediately and any excess amount paid towards Transport Allowance till date be recovered forthwith.
